



## Glen Meadows

### 5K/10K/15K

The beautiful Greylock Glen is the site for this new "trail race". The DCR has created a gorgeous 1.5 mile loop of packed gravel about 15' wide that runs around a couple of small ponds through the meadows at Greylock Glen with mountain views in all directions. 2 loops (+ a little bit) for the 5K, 4 loops (+ a little bit more) for the 10K and 6+ loops for the 15K. A water station every 1.5 miles as you make the loop. Make sure to pack blankets and chairs and a picnic basket for after the race!
